

## SOFTWARE LICENSE TERMS AND CONDITIONS

**IMPORTANT NOTICE:** THESE SOFTWARE LICENSE TERMS AND CONDITIONS (“SOFTWARE TERMS”) GOVERN THE USE BY THE INDIVIDUAL OR ENTITY END USER (“CUSTOMER,” “END USER,” “YOU” OR “YOUR”) WHO PURCHASED A LICENSE TO THE COMPUTER SOFTWARE (AS DESCRIBED FURTHER IN SECTION 1, THE “SOFTWARE”) FROM BCD SOFTWARE, LLC (“BCD SOFTWARE,” “WE,” “OUR” OR “US”) OR ITS AUTHORIZED RESELLER SET FORTH ON THE EXECUTED BUSINESS PROPOSAL (“BUSINESS PROPOSAL”). WE ARE WILLING TO LICENSE THE SOFTWARE TO YOU ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THESE SOFTWARE TERMS. IF YOU DO NOT AGREE TO ALL OF THESE SOFTWARE TERMS, THEN WE ARE UNWILLING TO PROVIDE YOU WITH THE SOFTWARE, IN WHICH EVENT YOU SHOULD RETURN THE UNUSED SOFTWARE TO US OR TO OUR AUTHORIZED RESELLER WITHIN SEVEN (7) DAYS OF THE DATE OF PURCHASE FOR A FULL REFUND.

**1. SCOPE; OWNERSHIP.** These Software Terms govern your use of the Software received from us and/or our licensors or suppliers. The Software is licensed, not sold, and we or our licensors retain title, ownership rights, intellectual property rights and all other rights not expressly granted to you in these Software Terms in and to the computer programs and the operating instructions, user manuals, help files, and other technical information and materials, in written, electronic or online form, intended for use in connection with the Products (“Documentation”) and other content transmitted to you by us (or our licensors and suppliers) at any time, including any updates, supplements, revisions, modifications, add-on components and Internet components, and all other copies thereof that you are authorized to make, regardless of the form or media on or in which the original or any copy may exist (collectively, the “Software”). You agree to abide by the patent, copyright, trademark and trade secret laws and all other applicable laws related to your use of the Software, including, but not limited to, United States export control laws. Nothing in these Software Terms constitutes a waiver of our or our licensors’ rights under U.S. or international patent, copyright, trademark or trade secret law or any other applicable law.

### **2. LICENSE.**

(a) Grant. We grant you a non-transferable, non-exclusive, limited license to install and use, in object code form only, the number of copies of the Software set forth on the Business Proposal on the Designated Machine(s), solely for your internal use and subject to these Software Terms. If you wish to install or use more copies of the Software, you must acquire and pay for an additional license(s) from us. For the purpose of these Software Terms, “Designated Machine” means the computer hardware and operating environment identified on the Business Proposal.

(b) Restrictions. These Software Terms do not permit you or any third party: (i) to modify, translate, reverse engineer, decompile or disassemble (except to the extent expressly allowed under applicable law without possibility of waiver) the Software or otherwise attempt to discover the source code of all or any portion of the Software; (ii) to modify, unbundle, translate or create derivative works of all or any portion of the Software; (iii) to copy the Software (other than a single copy of the Software solely for inactive back-up or archival purposes, and provided that such copy includes all copyright, government restricted rights and other proprietary notices or legends included on the Software); (iv) to use the Software for application development purposes; (v) to allow third parties to remotely access and use the Software over the Internet; (vi) to sell, resell, license, sublicense, rent, lease, timeshare, offer to sell or host the Software; (vii) to act as a facility manager, service bureau, ISV, VAR or OEM with respect to the Software; (viii) to in any other way distribute or transfer the Software to any third party; or (ix) to remove any proprietary markings, copyright notices, government restricted rights notices, logos, trademarks, trade names or labels on the Software and/or Documentation. Except as expressly set forth in this Section 2, no licenses of any kind are granted hereunder, whether by implication, estoppel or otherwise. You acknowledge that the Software may include features that ensure that your use of the Software complies with these Software Terms.

(c) Term and Termination. The Software licenses granted hereunder will continue unless otherwise terminated. You may terminate the Software licenses at any time by destroying or returning to us all copies of the Software and Documentation (in all forms and types of media, whether installed or not). The Software licenses will also terminate immediately without notice if you breach any provision of these Software Terms. Upon any termination, you must immediately destroy or return to us all copies of the Software and Documentation (in

all forms and types of media, whether installed or not). Upon our request, you shall provide us with an officer's written statement certifying to your compliance with this subsection.

**3. CONFIDENTIALITY.** You acknowledge that the Software contains proprietary and confidential property of us and/or our licensors embodying trade secrets. You agree: (a) to maintain the Software in confidence and use a reasonable degree of care to protect the confidentiality of the Software; and (b) to not disclose, provide or otherwise make available the Software to any person other than your employees or contractors who need to have access to it to carry out their duties and who are bound by written agreements to protect the confidentiality of the Software.

#### **4. WARRANTY.**

(a) Limited Warranty. We warrant to you that for ninety (90) days from the date of purchase, the Software will perform substantially in accordance with its then-current Documentation, provided that you implement all releases, enhancements and corrections offered to you. If the Software fails to comply with such warranty (a "Defect"), we will, at our option, repair or replace the Software. Any replacement Software will be warranted as above for the remainder of the original warranty period, or thirty (30) days from the date we provide it to you, whichever is longer. This is your sole and exclusive remedy for a breach of the above limited warranty.

(b) Exceptions. Neither we nor our licensors or vendors shall have any responsibility for: (i) correcting errors in any Software that has been modified, repaired or altered by you or any third party; (ii) errors due to a failure of computer hardware, equipment or software not provided by us; (iii) accident, neglect, misuse, failure of electric power, adverse environmental conditions, catastrophe or your negligence or improper use, or (iv) any Software that has not been maintained in accordance with the Documentation.

(c) Disclaimer of Warranties. TO THE EXTENT ALLOWED BY LAW, EXCEPT AS SET FORTH ABOVE, WE AND OUR LICENSORS AND SUPPLIERS DISCLAIM ANY AND ALL WARRANTIES AND CONDITIONS, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ALL WARRANTIES OF QUALITY, PERFORMANCE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, CORRESPONDENCE TO DESCRIPTION, QUIET ENJOYMENT, TITLE AND NON-INFRINGEMENT. NEITHER WE NOR OUR LICENSORS OR SUPPLIERS WARRANT THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT ITS USE WILL BE UNINTERRUPTED OR ERROR-FREE. Some jurisdictions do not allow the

exclusion of implied warranties, so the above exclusions may not apply to you.

**5. LIMITATION OF LIABILITY.** NEITHER WE NOR OUR LICENSORS OR VENDORS SHALL BE LIABLE FOR SPECIAL, INCIDENTAL, EXEMPLARY, CONSEQUENTIAL OR INDIRECT DAMAGES IN CONNECTION WITH THESE SOFTWARE TERMS OR THE SOFTWARE, INCLUDING BUT NOT LIMITED TO LOST PROFITS, LOST SAVINGS, OR DAMAGES ARISING FROM LOSS OF USE, LOSS OF CONTENT OR LOSS OF DATA, REGARDLESS OF THE LEGAL THEORY ON WHICH SUCH DAMAGES MAY BE BASED, AND EVEN IF WE OR OUR LICENSORS OR VENDORS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH IN THESE SOFTWARE TERMS FAILS OF ITS ESSENTIAL PURPOSE. NEITHER WE NOR OUR LICENSORS OR VENDORS SHALL HAVE ANY LIABILITY FOR ANY DAMAGES ARISING FROM THE USE OF THE SOFTWARE IN ANY HIGH-RISK ACTIVITY, INCLUDING, BUT NOT LIMITED TO, THE OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL, MEDICAL CARE SYSTEMS, LIFE SUPPORT OR WEAPONS SYSTEMS. OUR AND OUR LICENSORS' AND VENDORS' AGGREGATE LIABILITY UNDER THESE SOFTWARE TERMS WILL BE LIMITED TO THE AMOUNT PAID BY YOU FOR THE SOFTWARE GIVING RISE TO THE LIABILITY IN THE PRECEDING TWELVE (12) MONTH PERIOD. ADDITIONALLY, IN NO EVENT SHALL OUR LICENSORS (AND THEIR LICENSORS) BE LIABLE FOR ANY DIRECT DAMAGES UNDER THESE SOFTWARE TERMS.

**6. U.S. GOVERNMENT RESTRICTED RIGHTS.** The Software was developed at private expense and with no government funds. If any Software or Documentation is acquired by or on behalf of a unit or agency of the United States government ("U.S. Government"), the U.S. Government agrees that such Software or Documentation is "commercial computer software" or "commercial computer software documentation" and that, absent a written agreement to the contrary, the U.S. Government's rights with respect to such Software or Documentation are limited by these Software Terms pursuant to applicable regulations, including but not limited to FAR 12.212(a); FAR 52.227-14 and 52.227-19; DFARS 227.7202-1(a) and 227.7202-3(a); and DFARS 252.227-7013(c)(1)(ii). The Software and Documentation are proprietary data, all rights to which are reserved under the copyright laws of the United States.

**7. EXPORT.** You agree to comply with all export and re-export laws and regulations imposed by the U.S.

Government and the government of the United Kingdom with respect to the Software, the Documentation and any other technical data received from us.

between these Software Terms and the General Terms, the General Terms shall control.

**8. AUDIT.** During the term of the license(s) granted pursuant to these Software Terms and for one (1) year after the termination thereof, upon reasonable prior notice and during normal business hours, we shall have the right to audit your records relating to the Software to verify your compliance with these Software Terms. You agree to retain such records for a period of three (3) years.

**9. GOVERNING LAW.** These Software Terms are governed by and construed in accordance with the laws of The Commonwealth of Massachusetts and the federal U.S. laws applicable therein, excluding its choice of law provisions, and you agree to submit to the personal and exclusive jurisdiction of the courts located in Suffolk County, Massachusetts. Notwithstanding the foregoing, you acknowledge that a breach by you of these Software Terms may cause irreparable harm to us or our licensors for which a remedy at law would be inadequate, and therefore you agree that we may have the right to seek immediate injunctive relief to enforce these Software Terms, in addition to any other rights and remedies we or our licensors may have. You acknowledge and agree that the United Nations Convention on Contracts for the International Sale of Goods will not apply to these Software Terms. The remedies contained herein are cumulative and in addition to any other remedies at law or equity.

**10. MISCELLANEOUS.** You may not assign your rights or delegate your obligations under these Software Terms without our prior written consent. The failure of either party to require performance by the other party of any provision of these Software Terms shall not affect its right to require such performance at any time thereafter; nor shall the waiver by either party of a breach of any provision of these Software Terms be taken or held to be a waiver of the provision itself. If any provision of these Software Terms is found void and unenforceable, it will be replaced to the extent possible with a provision that comes closest to the meaning of the original provision. These Software Terms, and the documents referenced in these Software Terms, is the entire agreement between Customer and BCD Software relating to the license of the Software and supersedes any and all prior or contemporaneous purchase order, invoice, communication, advertising, representation, understanding or agreement concerning the license of the Software. These Software Terms may only be amended or modified by a writing that is signed by the duly authorized representatives of both parties.

**12. ORDER OF PRECEDENCE.** These Software Terms supplement the General Terms. In the event of any conflict
